We are proud to state that, within an existence of 15 years, Sri Balaji Society is known not only for its best infrastructure but also for the best faculties.

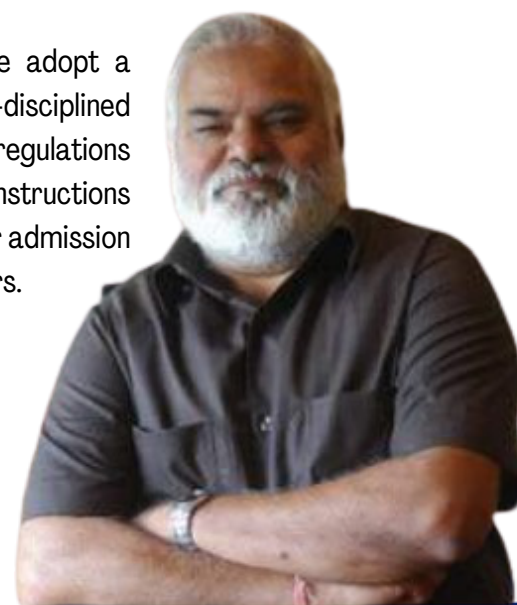

### ELIGIBILITY

#### **B.A.LL.B. (5 Year Law Course)**

**Academic qualification** – Higher Secondary School Certificate Examination (10+2) or its equivalent with 45% marks. There shall be relaxation of 5% marks in case of SC/ST students within the state of Maharashtra. Non-Zero Score in MAH-LLB-5 CET will not be eligible for the admission.

Applicants who have obtained 10+2 higher secondary pass certificate or first-degree certificate after prosecuting studies in distance or correspondence method are eligible for admission in the integrated five-year course.

Applicants who have obtained 10+2 or graduation / post-graduation through open universities system, directly without having any basic qualification for prosecuting such studies are NOT ELIGIBLE for admission in law course.

#### **LL.B. (3 Year Law Course)**

## State of Art Campus

A spacious campus of 3.6 acres provides an ambience for a healthy teaching and learning atmosphere. The college is located in Tathawade, near Hinjewadi IT Park and surrounded by various prestigious educational institutions. The campus covers **Canteen, Playground, Volleyball court, Lawn, etc.**

The library houses a total of 20,219 books, including 6,100 reference books, 2,950 general books, 1,797 old and rare bound journals, 9 journals (6 national and 3 international), 5 law case reports, 7 periodicals (Current Academic Year), and 9 newspapers. It also has 1 computer lab consisting of 50 computers.

Students are allowed to borrow 10 books at a time for a period of 30 days (books can be renewed after 30 days). The library subscribes to all leading newspapers, periodicals, and National and international magazines. Students, faculty members, and scholars are encouraged to recommend as many books of international standards as required by them.

The library is open to students during college hours, with book issuing timings between 8:00 a.m. and 4:00 p.m. We also have access to the Central Library of Sri Balaji University and are members of Jaykar Library (Savitribai Phule Pune University, Pune) which contains a wide collection of international books, reference books related to Legal aspects and the international scenario, with a spacious and well-furnished reading hall.

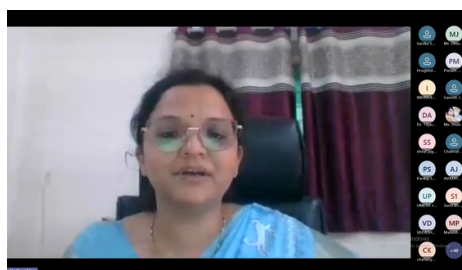




## RESEARCH CELL

# Anti Ragging Committee

Sri Balaji Society's Balaji Law College, Tathwade – Pune and its administration are deeply committed to upholding a safe and respectful environment for all its students. The college conforms with all the anti-ragging guidelines issued by the University Grants Commission, Savitribai Phule Pune University and the Government of Maharashtra. The college has a zero-tolerance towards ragging and has constituted an Anti-Ragging Committee headed by the Head of the Institution and a diverse mix of faculty, student members and non-teaching staff to avoid any form of conflict that could take the ugly form of ragging.

## **OBJECTIVES:**

1. To create awareness among the students of dehumanizing effect of ragging inherent in its perversity.
2. To keep a continuous watch and vigil over ragging so as to prevent its occurrence and recurrence.
3. To promptly and stringently deal with the incidents of ragging brought to our notice.
4. To generate an atmosphere of discipline by sending a clear message that no act of ragging shall be tolerated and any act of ragging shall not go unnoticed and unpunished.

## **WHAT CONSTITUTES RAGGING?**

Ragging constitutes one or more of any of the following acts:

1. Any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student.
2. Indulging in rowdy or undisciplined activities by any student or students which causes or is likely to cause annoyance, hardship, physical or psychological harm or to raise fear or apprehension thereof in any fresher or any other student.
3. Asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating a sense of shame, or torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any other student.
4. Any act by a senior student that prevents, disrupts or disturbs the regular academic activity of any other student or a fresher.
5. Exploiting the services of a fresher or any other student for completing the academic tasks assigned to an individual or a group of students.
6. Any act of financial extortion or forceful expenditure burden put on a fresher or any other student by students
7. Any act of physical abuse including all variants of it: sexual abuse, homosexual assaults, stripping, forcing obscene and lewd acts, gestures, causing bodily harm or any other danger to health or person;
8. Any act or abuse by spoken words, emails, post, public insults which would also include deriving perverted pleasure, vicarious or sadistic thrill from actively or passively participating in the discomfiture to fresher or any other student.

9. Any act that affects the mental health and self- confidence of a fresher or any other student with or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student over any fresher or any other student.
10. Any act of physical or mental abuse (including bullying and exclusion) targeted at another student (fresher or otherwise) on the ground of colour, race, religion, caste, ethnicity, gender (including transgender), sexual orientation, appearance, nationality, regional origins, linguistic identity, place of birth, place of residence or economic background.

### **INSTITUTIONAL MEASURES FOR PROHIBITION OF RAGGING**

1. College has a functional Anti-Ragging Committee comprising of Head of the Institution, faculty members, student members and non-teaching staff.
2. Anti-Ragging Squad keeps vigilance in the college premises by conducting surprise visits and report to the committee any matter of ragging which comes or is brought to their notice.
3. Details of the members of the Anti-Ragging Committee and Anti-Ragging Squad are displayed on the college notice board, college website and college premises.
4. College premises are under CCTV Surveillance.
5. Orientation of the students and sensitizing the senior students towards the newcomers by the Head of the Institution and the Anti-Ragging Committee during the orientation program. Additionally, periodically awareness sessions and guest lectures are also organised so as to sensitize the students. The institution also observes Anti-Ragging Week and students too, actively promote the institutions' zero tolerance policy against ragging.
6. During admission, enrolment or registration must be accompanied by an Anti-Ragging affidavit signed by a student in a prescribed format and another Anti-Ragging Affidavit signed by a Parent/Guardian. (Both these Affidavits can be downloaded from [www.antiragging.in](http://www.antiragging.in) or [www.amanmovement.org](http://www.amanmovement.org))
7. The institution also takes strict action in accordance with the regulations framed by UGC, SPPU and Govt. of Maharashtra, against those found guilty of ragging and/or abetting ragging, actively or passively, or being part of a conspiracy to promote ragging.

### **PUNISHMENT IN THE EVENT OF RAGGING:**

The institution shall punish a student found guilty of ragging after following due procedure and prescribe any of the following punishments:

1. Suspension from attending classes and academic privileges.
2. Withholding/ withdrawing scholarship/ fellowship and other benefits.
3. Debarring from appearing in any test/ examination or other evaluation process.
4. With holding results.
5. Debarring from representing the institution in any regional, national or international meet, tournament, youth festival, etc.
6. Cancellation of admission.



7. Rustication from the institution for a period ranging from one to four semesters.
8. Expulsion from the institution and consequent debarring from admission to any other institution for a specified period.
9. Fine ranging between Rupees 25,000/- and Rupees 1 lakh.
10. Collective punishment: When the persons committing or abetting the crime of ragging are not identified, the institution shall resort to collective punishment.

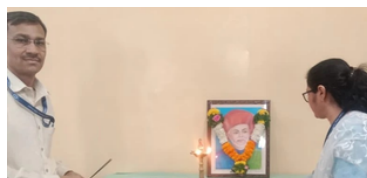

- Uniform is compulsory on all days except for Saturday.

# Code Of Conduct For Students

## A. Preamble

Each student is admitted to the Balaji Law College under the condition that their conduct meets the standards established by Sri Balaji Society.

## B. Standards of Conduct

### **1. Academic Honesty-**

The college values academic, intellectual and ethical integrity. Students must ensure highest standards of academic integrity. Violation of academic integrity would constitute a serious misconduct.

**2. Class Attendance and Course Requirements-** It is a violation of this student code to intentionally indicate the presence of another student who is not actually present in class or to misrepresent one's own presence or absence.

**3. Misappropriation and Misuse of Property** - It is a violation of this student code to:

- a. Damage, hide, or exert unauthorized control over property belonging to another person or the College.
- b. Obtain or attempt to obtain unauthorized access to college records, databases, communications, or student emails.
- c. Use the law college's computer or email systems in violation of regulations or to support conduct that breaches this code.

**4. Illegal and Criminal Conduct-** It is a violation of this student code to:

- a. Possess, use, or distribute illegal drugs on college property or during college-sponsored activities.
- b. Indulge in any and all forms of misconduct including taking or being a part of any activity off-campus which can affect the interests and reputation of the institute.
- c. Indulge in any ant-national activity that threatens communal harmony, integrity and sovereignty of the nation

**5. Obstruction of Disciplinary Proceedings-** It is a violation of this student code to:

- a. Testify falsely or provide false information during a disciplinary violation process.
- b. Bring a charge in bad faith under this Code or the Rules for Student Disciplinary Proceedings.
- c. Harass individuals providing information or testimony related to alleged violations or participating in enforcement.
- d. Submit false allegations of misconduct in a disciplinary investigation.
- e. Breach confidentiality requirements regarding disciplinary proceedings.

### **6. Campus Behavior and Environment**

1. **Noise and Disturbances:** Students should maintain a conducive learning environment by avoiding excessive noise, disruptive behavior, or any activity that hampers the academic atmosphere on campus.
2. **Use of Technology:** The use of electronic devices, including smartphones and laptops, should not be allowed in classroom except with the permission of subject in charge.

1. **WARNING** – Indicating that the action of the delinquent student was in violation of the Code and any further acts of misconduct shall result in severe disciplinary action
  2. **RESTRICTIONS** – Reprimanding and Restricting access to various facilities on the campus for a specified period of time.
  3. **COMMUNITY SERVICE** – Ordering the Student to do certain community services within or outside the campus for a specified period of time.
  4. **MONETARY PENALTY** – A student may be imposed with monetary penalty of one time fine/suspension or forfeiture of scholarship/fellowship for a specific time period.
  5. **SUSPENSION** – Student shall be imposed with punitive suspension for a specified period which will entail prohibition on participating in student related activities, classes, programs etc.
  6. **EXPULSION** – Expulsion of a student from the College permanently.
